This supplement (the "**Supplement**") is the sixth supplement to the offering circular dated 26 June 2018, as supplemented by the first supplement dated 29 August 2018, the second supplement dated 31 October 2018, the third supplement dated 18 December 2018, the fourth supplement dated 28 February 2019 and the fifth supplement dated 07 March 2019, (the "**Offering Circular**") of the Euro 20,000,000,000 Programme for the Issuance of Debt Instruments (the "**Programme**") of NIBC Bank N.V. (the "**Issuer**") and is prepared to update and amend the Offering Circular and is supplemental to, forms part of and should be read in conjunction with the Offering Circular, with any documents incorporated by reference therein, which, in relation to any Notes that are the subject of Final Terms, must be read and construed together with the relevant Final Terms. Terms defined in the Offering Circular shall have the same meaning in this Supplement, unless specified otherwise.

This document is an amendment and a supplement to the Offering Circular within the meaning of article 16 of Directive 2003/71/EC including Directive 2010/73/EU (the "**PD Amending Directive**") (the "**Prospectus Directive**"). This Supplement has been approved by the Dutch Authority for the Financial Markets (*Stichting Autoriteit Financiële Markten*, the "**AFM**") in its capacity as competent authority under the Prospectus Directive and Dutch securities laws.

AMENDMENTS TO THE OFFERING CIRCULAR

This Supplement is prepared in connection with ratings provided by both Standard & Poor's and Fitch following the first issue of Senior Non-Preferred Notes on 09 April 2019 and the subsequent distinction in rating between Senior Preferred Notes and Senior Non-Preferred Notes.

The above qualifies as a significant new factor relating to the information included in the Offering Circular which is capable of affecting the assessment of any Notes to be issued.

The above shall be deemed to be incorporated in, and to form part of, this Supplement. This Supplement is supplemental to, forms part of and should be read in conjunction with, the Offering Circular. Terms defined in this Supplement shall have the same meaning in the Offering Circular, unless specified otherwise.

To the extent that there is any inconsistency between (a) any statement in this Supplement or any statement incorporated by reference by means of this Supplement into the Offering Circular, and (b) any other statement in or incorporated by reference in the Offering Circular, the statements under (a) above will prevail.

The following amendment is made to the text of the Offering Circular:

In the chapter "OVERVIEW OF THE PROGRAMME", on page 39, paragraph "Ratings", the following wording shall be deleted:

"Senior Preferred Notes issued under the Programme will initially be rated BBB by Standard & Poor's and BBB by Fitch."

and shall be replaced with:

"Senior Preferred Notes issued under the Programme will initially be rated BBB by Standard & Poor's and BBB+ by Fitch. Senior Non-Preferred Notes issued under the Programme will initially be rated BBB- by Standard & Poor's and BBB by Fitch."
