This supplement (the "Supplement") is the fourth supplement to the offering circular dated 27 June 2022, as supplemented by the first supplement dated 24 August 2022, the second supplement dated 12 January 2023 and the third supplement dated 10 March 2023 (the "Offering Circular") of the Euro 20,000,000,000 Programme for the Issuance of Debt Instruments (the "Programme") of NIBC Bank N.V. (the "Issuer") and is prepared to update and amend the Offering Circular and is supplemental to, forms part of and should be read in conjunction with the Offering Circular, with any documents incorporated by reference therein. Full information on the Issuer and any Series or Tranche of Notes is only available on the basis of the combination of the Offering Circular, this Supplement and the applicable Final Terms. Terms defined in the Offering Circular shall have the same meaning in this Supplement, unless specified otherwise.

The Offering Circular constitutes a base prospectus within the meaning of Regulation (EU) 2017/1129 (as amended) (the "**Prospectus Regulation**"). This document is a supplement to the Offering Circular within the meaning of Article 23 of the Prospectus Regulation.

This Supplement has been approved by the Dutch Authority for the Financial Markets (*Stichting Autoriteit Financiële Markten*, the "AFM"), as competent authority under the Prospectus Regulation. The AFM only approves this Supplement as meeting the standards of completeness, comprehensibility and consistency imposed by the Prospectus Regulation. Such approval should not be considered as an endorsement of the Issuer nor as an endorsement of the quality of any Notes that are the subject of this Supplement. #### AMENDMENTS TO THE OFFERING CIRCULAR

This Supplement is prepared in connection with the downgrade on NIBC's long-term issuer credit ratings by Standard & Poor's on 17 March 2023 to BBB from BBB+.

The above qualifies as significant new factors relating to the information included in the Offering Circular which is capable of affecting the assessment of any Notes to be issued.

To the extent that there is any inconsistency between (a) any statement in this Supplement or any statement incorporated by reference by means of this Supplement into the Offering Circular, and (b) any other statement in or incorporated by reference in the Offering Circular, the statements under (a) above will prevail.

The following amendments are made to the text of the Offering Circular:

1. In the chapter "OVERVIEW OF THE PROGRAMME", on page 9, under "Ratings", the following wording shall be deleted:

"If the relevant Tranche of Notes is rated, it is expected that (i) in the case of Senior Preferred Notes issued under the Programme, such Notes will initially be rated BBB+ by Standard & Poor's and BBB+ by Fitch or Fitch Ratings Limited and that (ii) in the case of Senior Non-Preferred Notes issued under the Programme, such Notes will initially be rated BBB- by Standard & Poor's and BBB by Fitch or Fitch Ratings Limited."

and shall be replaced with:

"If the relevant Tranche of Notes is rated, it is expected that (i) in the case of Senior Preferred Notes issued under the Programme, such Notes will initially be rated BBB by Standard & Poor's and BBB+ by Fitch or Fitch Ratings Limited and that (ii) in the case of Senior Non-Preferred Notes issued under the Programme, such Notes will initially be rated BBB- by Standard & Poor's and BBB by Fitch or Fitch Ratings Limited."

2. In the chapter "IMPORTANT NOTICES", on page 50, paragraph "Ratings", the following wording shall be deleted:

"The Issuer has long- and short- term issuer credit rating of BBB+/A-2 issued by S&P Global Ratings Europe Limited ("Standard & Poor's" or "S&P") and long- and short- term issuer default rating of BBB/F3 issued by Fitch Ratings Europe Limited ("Fitch")."

and shall be replaced with:

"The Issuer has long- and short- term issuer credit rating of BBB/A-2 issued by S&P Global Ratings Europe Limited ("Standard & Poor's" or "S&P") and long- and short- term issuer default rating of BBB/F3 issued by Fitch Ratings Europe Limited ("Fitch")."

3. In the chapter "BUSINESS DESCRIPTION OF NIBC BANK N.V.", on page 163, paragraph "Ratings", the following table shall be deleted:
