(the "**Issuer**") and is prepared to update and amend the Offering Circular and is supplemental to, forms part of and should be read in conjunction with the Offering Circular, with any documents incorporated by reference therein, which, in relation to any Notes that are the subject of Final Terms, must be read and construed together with the relevant Final Terms. Terms defined in the Offering Circular shall have the same meaning in this Supplement, unless specified otherwise.

This document is an amendment and a supplement to the Offering Circular within the meaning of article 16 of Directive 2003/71/EC including Directive 2010/73/EU (the "**PD Amending Directive**") (the "**Prospectus Directive**"). This Supplement has been approved by the Dutch Authority for the Financial Markets (*Stichting Autoriteit Financiële Markten*, the "**AFM**"), which is the Dutch competent authority for the purpose of the Prospectus Directive and relevant implementing measures in the Netherlands, as a supplemental prospectus issued in compliance with the Prospectus Directive, Commission Regulation EC No. 809/2004 (the "**Prospectus Regulation**") and relevant implementing measures in the Netherlands for the purpose of giving information with regard to the issue of Notes under the Programme.

### AMENDMENTS TO THE OFFERING CIRCULAR

This Supplement is prepared in connection with the finalisation of the acquisition of SNS Securities N.V. by the Issuer. SNS Securities N.V. has been renamed NIBC Markets N.V.

The above qualifies as a significant new factor relating to the information included in the Offering Circular which is capable of affecting the assessment of any Notes to be issued.

This Supplement is supplemental to, forms part of and should be read in conjunction with, the Offering Circular. Terms defined in this Supplement shall have the same meaning in the Offering Circular, unless specified otherwise.

To the extent that there is any inconsistency between (a) any statement in this Supplement or any statement incorporated by reference into the Offering Circular, and (b) any other statement in or incorporated by reference in the Offering Circular, the statements under (a) above will prevail.

The following amendment is made to the text of the Offering Circular:

1. In the chapter "RISK FACTORS", page 20, the following text shall be deleted:

"The Issuer and SNS Bank N.V. have reached an agreement on the acquisition of SNS Securities N.V. ("SNS Securities"), which is subject to the fulfilment of conditions precedent which may or may not be fulfilled. If they are, the Issuer faces risks relating to the integration of SNS Securities into the Issuer's existing business.

SNS Securities provides capital market solutions, equity and fixed income brokerage, research and execution services for independent asset managers. The conditions precedent in the agreement between the Issuer and SNS Bank N.V. for the acquisition of SNS Securities may not be fulfilled. In the event that the agreement for the acquisition of SNS Securities becomes effective, the Issuer faces risks relating to the integration of SNS Securities into the Issuer's existing business. Failure to integrate SNS Securities effectively into the existing business of the Issuer may have an adverse effect on the Issuer's financial conditions and/or results of operations."

and shall be replaced with:

## "The Issuer has finalised the acquisition of SNS Securities N.V. on 30 June 2016. SNS Securities N.V. will continue under the name NIBC Markets N.V. ("NIBC Markets"). The Issuer faces risks relating to the integration of NIBC Markets into the Issuer's existing business.

NIBC Markets provides capital market solutions, equity and fixed income brokerage, research and execution services for independent asset managers. The Issuer faces risks relating to the integration of NIBC Markets into the Issuer's existing business. Failure to integrate NIBC Markets effectively into the existing business of the Issuer may have an adverse effect on the Issuer's financial conditions and/or results of operations."

2. In the chapter "BUSINESS DESCRIPTION OF NIBC BANK N.V.", section "3.6 **Business Overview**", page 152, the following text shall be deleted:

"*Corporate Banking* activities cover advice, financing and co-investment provided primarily to medium-sized companies in the Benelux, Germany and the United Kingdom."

and shall be replaced with:

"*Corporate Banking* activities cover advice, financing and co-investment provided primarily to medium-sized companies and, via NIBC Markets, capital market solutions, equity and fixed income brokerage, research and execution services for independent asset managers. Corporate Banking activities predominantly focus on the Benelux, Germany and the United Kingdom."

3. In the chapter "BUSINESS DESCRIPTION OF NIBC BANK N.V.", section "3.7 **Subsidiaries**", page 153, the following subsidiaries shall be added:

"Securities Holding B.V., the Netherlands and NIBC Markets N.V., the Netherlands"
