## **Programme for the Issuance of Debt Instruments**

This supplement (the "Supplement") is the sixth supplement to the offering circular dated 24 June 2020, as supplemented by the first supplement dated 15 July 2020, the second supplement dated 26 August 2020, the third supplement dated 21 September the fourth supplement dated 16 October 2020 and the fifth supplement dated 20 January 2021 (the "Offering Circular") of the Euro 20,000,000,000 Programme for the Issuance of Debt Instruments (the "Programme") of NIBC Bank N.V. (the "Issuer") and is prepared to update and amend the Offering Circular and is supplemental to, forms part of and should be read in conjunction with the Offering Circular, with any documents incorporated by reference therein. Full information on the Issuer and any Series or Tranche of Notes is only available on the basis of the combination of the Offering Circular, this Supplement and the applicable Final Terms. Terms defined in the Offering Circular shall have the same meaning in this Supplement, unless specified otherwise.

The Offering Circular constitutes a base prospectus within the meaning of Regulation (EU) 2017/1129 (as amended) (the "**Prospectus Regulation**"). This document is a supplement to the Offering Circular within the meaning of Article 23 of the Prospectus Regulation.

This Supplement has been approved by the Dutch Authority for the Financial Markets (*Stichting Autoriteit Financiële Markten*, the "AFM"), as competent authority under the Prospectus Regulation.
